Cancer in the workplace

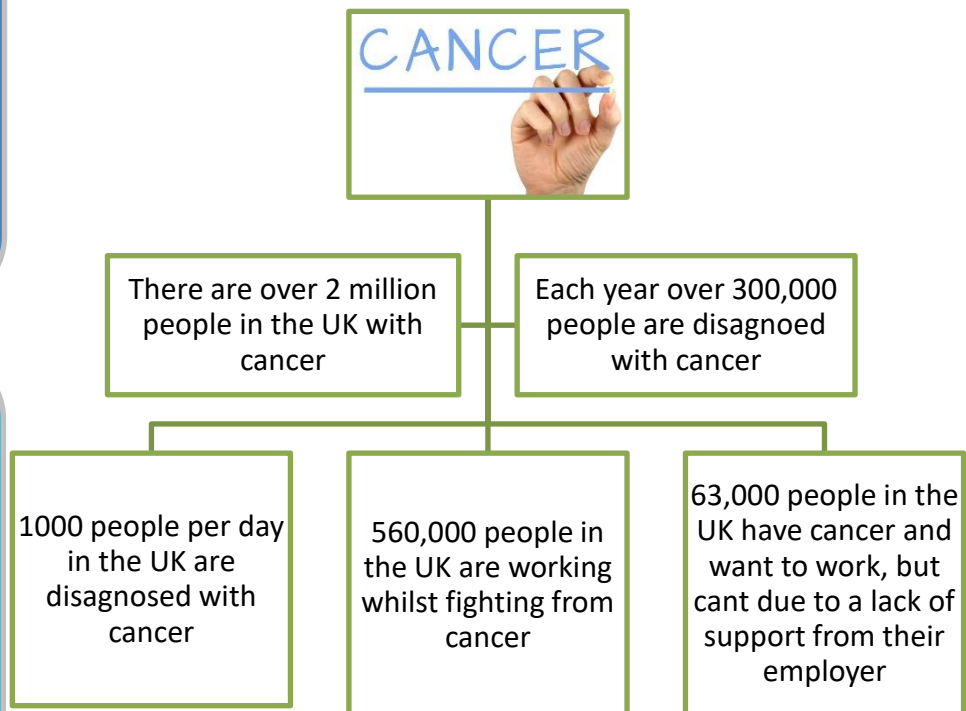

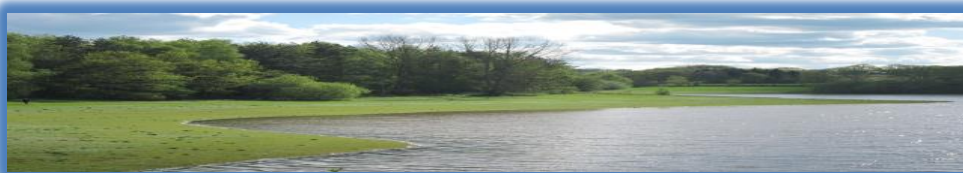
